JUDGMENT

- [1] **ON READING** North American Lithium Inc. ("**NAL**")'s *Motion for an Order Extending the Stay period* (the "**Motion**"), the exhibit, the Second Report of the Monitor dated June 26, 2019 and the sworn statement of Ms. Janet Huang filed in support thereof;
- [2] **GIVEN** the representations of counsel;
- [3] **GIVEN** the terms of the *Initial Order* of this Court dated May 28, 2019 ("the "**Initial Order**") and the provisions of the *Companies' Creditors Arrangement Act*, RSC 1985, c. C-36 (the "**CCAA**").

FOR THESE REASONS, THE COURT:

- [4] **GRANTS** the present Motion.

Service

- [5] **ORDERS** that any prior delay for the presentation of this Motion, including the delay set forth in paragraph 41 of the Initial Order, is hereby abridged and validated so that this Motion is properly returnable today and hereby dispenses with further service thereof;
- [6] **DECLARES** that sufficient prior notice of the presentation of the Motion has been given by the Petitioner to all the stakeholders listed in the Service list attached thereto.

Extension of the Stay Period

- [7] **EXTENDS** the Stay Period ordered in the Initial Order until August 31, 2019;
- [8] **ORDERS** that paragraph 7 of the Initial Order shall be further amended as follows:
7. **ORDERS** that, until and including August 31, 2019, or such later date as the Court may order (the "**Stay Period**"), no proceeding or enforcement process in any court or tribunal (each, a "**Proceeding**") shall

be commenced or continued against or in respect of the Petitioner, or affecting the Petitioner's business operations and activities (the "**Business**") or the Property (as defined herein below), including as provided in paragraph 10 hereinbelow except with leave of this Court. Any and all Proceedings currently under way against or in respect of the Petitioner or affecting the Business or the Property are hereby stayed and suspended pending further order of this Court, the whole subject to subsection 11.1 CCAA.

[9] **ORDERS** the provisional execution of this Order notwithstanding any appeal;
