PLEASE READ THIS NOTICE

1. On February 5, 2019, Justice Pierre Ouellet of the Superior Court of Quebec rendered a ruling allowing members of the group to be compensated for damages due to red dust that settled during the month of October 2012. The ruling is posted on the court-appointed Administrator's website at: www.poussiererouge.com.

2. If you are a member of the following group, you may be compensated:

"Any individual who, on October 26, 2012, occupied a residential property, either as an owner or a tenant, located in the Québec City boroughs of Cité-Limoilou and Les Rivières, more specifically in the neighbourhoods defined by the following perimeters:

Red Zone:

Vieux-Limoilou: Between 9th street in the **North** and the St-Charles River in the **South** and from the St-Charles River in the **West** flowing **East** to Des Capucins Boulevard.

Pink Zone:

St-Roch: Between the St-Charles River from the intersection of Drouin Bridge and Croix-Rouge Street in the **North-West** and Prince-Édouard Street in the **South**, and between Laurentian autoroute (973) at Prince-Édouard Street in the **West** and Jean-Lesage Boulevard in the **East**.

Blue Zone:

Vieux-Limoilou: Between 15th Street and Espinay Street in the **North** and 10th Street in the **South** and between Laurentian autoroute (973) in the **West** and Des Capucins Boulevard northbound towards 8th Avenue in the **East**.

Vanier: Between Wilfrid-Hamel in the **North** and the St-Charles River in the **South**, and between Bourdages Street in the **West** and Laurentian autoroute (973) in the **East**.”

3. To submit a claim, you have to fill in the form posted on the following site: www.poussiererouge.com. You may also obtain a paper copy by contacting the claim Administrator at 1-877-266-0031 or at poussiererouge@rcgt.com. You may also complete the form by phone or in person with the assistance of the Administrator. Public meetings to explain the ruling and claim process will be held on September 17, October 17 and November 28, 2019 at the Centre communautaire Jean-Guy Drolet at 16 Royal-Roussillon Street in Québec City.
4. **Your claim form must be submitted to the Administrator no later than December 7, 2019** failing which you will not be compensated and will forfeit all of your rights in the class action. For more details about the process, go to the Administrator’s website www.poussiererouge.com.
