NOTICE OF A CLAIMS PROCEDURE ORDER AND INSTRUCTIONS TO THE CREDITORS

Notice is hereby given that an Order was rendered on December 13, 2022, under which the Court ordered the Monitor to send Proof of Claim forms to the known creditors of the Debtors. Any person who has not received such a Proof of Claim form and who believes that it holds a Claim against any of the Debtors which arose prior to the Determination Date¹, or that it holds a Claim which arose on or after the Determination Date, as a result of the restructuring, repudiation or termination of any contract, lease, employment, agreement or other agreement, whether unliquidated or contingent, against the Debtors or the directors and officers, with respect to the obligations of the Debtors, should send a duly completed Proof of Claim to the Monitor to be received no later than 4:00 p.m. (Montréal Time) on January 20, 2023 (the "Claims Bar Date"). The Proof of Claim must, among other things, specify if the Claim also encompasses the directors and/or officers of the Debtors.

CLAIMS WHICH ARE NOT RECEIVED BY THE CLAIMS BAR DATE WILL FOREVER BE BARRED AND EXTINGUISHED.
