- [15] REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada, in the United States of America or elsewhere, to give effect to this Order and these proceedings under the BIA and to assist, Lilianne, the NOI Trustee and their respective agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to Lilianne and the NOI Trustee, as an officer of this Court, as may be necessary or desirable to give effect to the Order, to grant representative status to the NOI Trustee in any foreign proceeding or to assist Lilianne, the NOI Trustee and their respect agents in carrying out this Order.
- [16] **ORDERS** the provisional execution of this Order notwithstanding any appeal and without the necessity of furnishing any security or provision for costs whatsoever;
- [17] **THE WHOLE** without costs.
