- [4] **CONSIDERING** the provisions of the *Bankruptcy and Insolvency Act* ("**BIA**");
- [5] **SEEING** the service of the Motion;
- [6] **CONSIDERING** the representations of counsel;

#### THE COURT HEREBY:

[7] **GRANTS** the Motion;

#### SERVICE

- [8] **ORDERS** that any prior delay for the presentation of the Motion is hereby abridged and validated so that the Motion is properly returnable today and hereby dispenses with any further service thereof;
- [9] **PERMITS** service of this Order at any time and place and by any means whatsoever;

#### **EXTENSION OF THE TIME TO FILE A PROPOSAL**

[10] ORDERS that the time within which to file a proposal pursuant to subsection 62(1) of the BIA and the corresponding stay of proceedings provided for in section 69 of the BIA, be and are hereby extended in accordance with subsection 50.4(9) of the BIA up to and including October 23, 2020;

#### GENERAL

- [11] ORDERS that the Trustee's Report on Statement of earning, Schedule A to the NOI Trustee's Report on the State of the Insolvent Person, and the Cash Flow Statement, the Cash Flow Statement and the Notes to the Cash Flow, Schedule B to the NOI Trustee's Report on the State of the Insolvent Person's Business and Financial Affairs, be kept confidential and under seal until further order of this Court or upon consent of Lilianne and of the NOI Trustee;
- [12] **DECLARES** that this Order and all other orders in these BIA proceedings shall have full force and effect in all provinces and territories in Canada;
- [13] **REQUESTS** the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada, in the United States of America or elsewhere, to give effect to this Order and these proceedings under the BIA and to assist, Lilianne, the NOI Trustee and their respective agents in carrying out the

terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to Lilianne and the NOI Trustee, as an officer of this Court, as may be necessary or desirable to give effect to the Order, to grant representative status to the NOI Trustee in any foreign proceeding or to assist Lilianne, the NOI Trustee and their respect agents in carrying out this Order;

- [14] **ORDERS** the provisional execution of this Order notwithstanding any appeal and without the necessity of furnishing any security-or-provision for costs whatsoever;
- [15] **THE WHOLE** without costs.
