This guide is designed to assist parties who wish to file a Proof of Claim against the Debtor Company listed below and/or directors and officers of Debtor Company with respect to the obligations of the Debtor Company. Please note that this document is only a guide. In case of disparity between the terms of this document and the terms of the *Claims Procedure Order* dated November 19, 2021 (the "**Order**"), the terms of the Order will prevail.

SECTION A – PARTICULARS OF CREDITORS

- 1. Every individual and every legal entity (each, a "Creditor") who wishes to make a claim against the Debtor Company (each, a "Claim") or against directors and/or officers of the Debtor Company must complete a separate form;
- 2. The Creditor must write his full legal name or, in the case of a company, his complete corporate name;
- 3. If the Creditor is conducting business with the Debtor Company under one or more names which are different from the name under which it is registered, that fact must be stated, and copies of the relevant documentation provided as applicable.

SECTION B - PROOF OF CLAIM

1. The Creditor who holds a Claim associated to a denunciation under the Civil Code of Quebec must expressly provide all the documents identified in the Proof of Claim.

SECTION C - NATURE OF CLAIM

- 1. The Creditor must separate the total amount of its Claim between amounts that are secured by a guarantee (security interest, hypothec, mortgage, etc.) and unsecured amounts, and indicate each on the appropriate line;
- 2. Certain amounts that may be due to Creditors are not Claims and must not be indicated in the Proof of Claim forms, including amounts that may be due under obligations arising on or after May 5, 2021.
