4. Such Subsequent Settling Parties are, as of the date this Settlement Certificate of the Monitor, fully, finally, absolutely, unconditionally, completely, irrevocably and forever released and discharged of any Product Claim of any Person; and
5. The amount of the Settlement is \$597,380.00, which is allocated amongst the Product Claims mentioned in Schedule "A" hereto.
