1. RONA Inc. and Royal & Sun Alliance Insurance Company of Canada, in its capacity as insurer of RONA Inc., as well as their respective subsidiaries, parents, affiliates, related companies, predecessors, successors, assigns, officers, directors, employees, representatives, shareholders, insurers, attorneys and agents are Subsequent Settling Parties;
2. The Monitor has entered into a Settlement with RONA Inc. and Royal & Sun Alliance Insurance Company of Canada, in its capacity as insurer of RONA Inc.;
3. The conditions precedent to such Settlement, to the exception of the filing of the Settlement Certificate of the Monitor, have been fulfilled or waived;
4. Such Subsequent Settling Parties are, as of the date this Settlement Certificate of the Monitor, fully, finally, absolutely, unconditionally, completely, irrevocably and forever released and discharged of any Product Claim of any Person; and
5. The amount of the Settlement is allocated amongst the Product Claims mentioned in Schedule "A" hereto.
