AMENDED NOTICE AND STATEMENT OF THE RECEIVER

(Subsections 245(1) and 246(1) of the Act)

On July 25, 2022, the Receiver notified the Insolvent company's only known creditors and declared the following:

1. On the 15th day of July 2022, the undersigned RAYMOND CHABOT INC., became the receiver in respect of the assets 1587431 Ontario Ltd., an Insolvent company, which is described below:
 - The Receiver's agent, Ontario Legal Recovery Ltd., attempted to take possession of the assets on Monday, July 18, 2022. When he arrived on site, most of all the vehicles and garage equipment had already been removed from the premises.
2. The undersigned became a Receiver in respect of the property described above pursuant to an order issued by the Ontario Superior Court of Justice on application of the secured creditor, Caisse Desjardins Ontario Credit Union Inc.
3. The undersigned did not take possession or control of the property described, since the remaining assets at the premises were of little to no value (mostly office furniture and scrap vehicles).
4. The following information relates to the receivership:
 - a) Address of Insolvent company: 416 First Street
London (Ontario) N5W 4N1
 - b) Principal line of business: Used car dealership and automobile service
 - c) Location(s) of business: Same as above
 - d) Prior to issuing the original Notice and Statement of the Receiver, due to the lack of cooperation from the insolvent company's director, Mr. Pablo Pelloni, the Receiver had not obtained the information necessary to prepare the list of creditors. The only known creditors were those who had registered security interests pursuant to the PPSA. Other than the amount owing to Caisse Desjardins Ontario Credit Union Inc., the Receiver had no information regarding amounts potentially owing to other secured or unsecured creditors.

Since the issuance of the original Notice and Statement of the Receiver, the undersigned has obtained from Mr. Pelloni, additional information regarding creditors. As such, the Receiver is issuing this Amended Notice and Statement of the Receiver.

- e) The updated list of other creditors of the Insolvent company and the amount owed to each creditor and the total amount due by the Insolvent company is attached as Exhibit A.
- f) The intended plan of action of the receiver during the receivership, to the extent that such a plan has been determined, is as follows:
- Vehicles registered to the Insolvent company have been identified with the assistance of Service Ontario.
 - A stolen vehicle report was filed with the London Police Department. However, the Receiver was advised that the vehicles were not considered stolen and, as such, the London Police Department would not pursue an investigation.
 - No other assets have been disclosed to or recovered by the Receiver.
