ORDER EXTENDING THE STAY OF PROCEEDINGS AND OF RECTIFICATION¹

CONSIDERING the submissions of the Debtors' attorneys and of other counsel present at the hearing on the Application;

CONSIDERING the Initial Order entered against the Debtors on May 12, 2023 (the "**Initial Order**");

CONSIDERING, pursuant to the Initial Order, the Stay Period ends on May 18, 2023;

CONSIDERING the provisions of the Initial Order, including paragraph 14 allowing for an oral request for an extension of the Stay Period, without the need for a written request or the filing of a Monitor's report;

CONSIDERING the provisions of the CCAA;

CONSIDERING it is also necessary to rectify a typo contained in the Initial Order, which contains an error as to the Court number in this file;

FOR THESE REASONS, THE COURT:

- [1] **DECLARES** that all capitalized terms used in this Order (the "**Order**") and not otherwise defined shall have the meaning given to them in the Initial Order;
- [2] **ORDERS** that the Stay Period and the operation of the Initial Order be extended to and including May 24, 2023;
- [3] **RECTIFIES** the Initial Order issued on May 12, 2023, for the sole purpose of changing the court number from "500-11-0623662-237" to "500-11-062362-237";
- [4] **GRANTS** service of this Order at any time, place and by any means, including email;
- [5] **DECLARES** that this Order and all other orders in this proceeding are fully enforceable and in force in all provinces and territories in Canada;
- [6] **REQUESTS** the assistance and recognition of any court or administrative agency of any province of Canada, any federal court or administrative agency of Canada, and any foreign court or administrative agency, if any, to assist the Court, the Debtors and the Monitor in enforcing the findings in this Order;
- [7] **ORDERS** the provisional execution of this Order notwithstanding any appeal, and without the requirement to provide any security or provisions for costs whatsoever.

THE WHOLE without costs.
