AND INSTRUCTIONS TO THE CREDITORS**

Notice is hereby given that an Order was rendered on January 20, 2016 under which the Court ordered the Monitor to send Proof of Claim forms to the known creditors of the Debtor Companies. Any person who has not received such a Proof of Claim form and who believes that it holds a Claim against any of the Debtor Companies which arose on or prior to December 20, 2015, or that it holds a Claim which arose on or after December 21, 2015 as a result of the restructuring, repudiation or termination of any contract, lease, employment, agreement or other agreement, whether unliquidated or contingent, **against the Debtor Companies, against the directors and officers of the Debtor Companies or against Intact compagnie d'assurance or La Garantie, compagnie d'assurance de l'Amérique du Nord as Bonding Companies of the Debtor Companies ("Bonding Companies"), with respect to the obligations of the Debtor Companies**, should send a duly completed Proof of Claim to the Monitor **to be received no later than 5:00 p.m. (EDT) on March 18, 2016** (the "**Claims Bar Date**"). The Proof of Claim must, among other things, specify if the Claim also encompasses the directors and/or officers of the Debtor Companies or one of the Bonding Companies.

**CLAIMS WHICH ARE NOT RECEIVED BY THE CLAIMS BAR DATE WILL FOREVER BE  
BARRED AND EXTINGUISHED.**
